FINAL PAPER SUBMISSION

To be included in the Conference Proceedings, your final paper must be uploaded to the [online submission site](#) no later than **June 30, 2020**. Your final submission should include the following:

1. Full paper, laid out in attached Word template. Paper must not exceed 2,500 words and include no more than five (5) high-resolution images (JPEG, PNG or Tiff), placed within the paper and also uploaded individually.
2. Full text for the following updated through the online system: Title, Abstract (up to 250 words), and Authors (all contributing authors, no more than four (4)).

Proceedings Template

All final papers must be formatted using the attached Word doc Template. Papers should be no longer than 2,500 words, excluding endnotes and captions, with a maximum of 5 images. Any citations should follow the Chicago Manual of Style. Final papers must be submitted online by **June 30, 2020** to be included in the Conference Proceedings.

Copyright Form

To be included in the conference proceedings UIA requires a completed copyright form so the congress has the permission to publish your paper.

Research/Rights (overview): First and foremost - the paper is your research. The copyright form gives ACSA the permission to publish your original paper. If your paper is included in future publications (such as a book chapter) we require that you simply note the paper was originally published in the 27th World Congress of Architects UIA 2020 RIO

Proceedings. If you expand on your published paper with 60% or greater new content, we do not require the inclusion of the original publisher.

Online Submission of Final Paper & Copyright

1. Log into the online submission site at <https://submissions.miramart.com/InternationalConference2020/Splash.aspx>. You cannot access this through ACSA's main site. If you forgot your password, please [click here](#).
2. Locate your accepted paper or design work. Click Continue to the left of the title.
3. Confirm that author names and institutions are correct. Click Save and Continue.
4. Make any changes to your title and abstract.
5. Upload your final paper with the following files:
 - Final Paper in word doc, word docx, or txt format,
 - Final Paper in PDF format,
 - Completed Copyright Form in PDF format.
6. Click Save and Continue.
7. Upload each image individually in JPEG, PNG, or TIFF format. If you do not have images, please check the box stating "I have no images to upload."
